(New Jersey Statutes Annotated) 30:13-18, new minimum staffing requirements for nursing homes," indicated the New Jersey Governor signed into law P.L. 2020 c 112, codified as N.J.S.A. 30:13-18 (the Act), which established minimum staffing requirements in nursing homes. The following ratio (s) were effective on 02/01/2021:</p> <p>One Certified Nurse Aide (CNA) to every eight residents for the day shift. One direct care staff member to every 10 residents for the evening shift, provided that no fewer of all staff members shall be CNAs and each direct staff member shall be signed into work as a certified nurse aide and shall perform nurse aide duties: and one direct care staff member to every 14 residents for the night shift, provided that each direct care staff member shall sign in to work as a CNA and perform CNA duties.</p> <p>The surveyor requested staffing for the weeks of 08/18/2024 to 08/31/2024, the facility was deficient in CNA staffing for residents on 3 of 14-day shifts, as follows:</p> <p>-08/18/24 had 13 CNAs for 116 residents on the day shift, required at least 14 CNAs. -08/24/24 had 13 CNAs for 111 residents on the day shift, required at least 14 CNAs. -08/25/24 had 12 CNAs for 111 residents on the day shift, required at least 14 CNAs.</p>	S 560	<p>until there are adequate staff to serve all residents. Until that time, the facility will utilize a staffing agency to fill any open spots in the schedule. Hiring and recruitment efforts including wage analysis and adjustments, online job listings, and referral bonuses are being utilized to become more competitive in the marketplace.</p> <p>4. The Administrator or designee will review staffing schedules with the scheduler weekly for three months to ensure adequate staffing for all shifts. The results of these reviews will be reviewed at our quarterly QAPI meeting.</p> <p>5. The Administrator is responsible for this plan of correction</p>
