PURPOSE FOR WHICH THE GRANT PROGRAM FUNDS SHALL BE USED:

The New Jersey Department of Health (NJDOH) - WISEWOMAN: Well-Integrated Screening and Evaluation for WOMen Across the Nation program seeks to fund evidence-based strategies to prevent and manage cardiovascular disease in women aged 35-64, at or below 250% of the Federal Poverty Level, are under-or-uninsured, and are enrolled in the National Breast and Cervical Cancer Early Detection Program (NBCCEDP). Funding will address the burden of cardiovascular disease and its risk factors by implementing prevention and self-management strategies, system-level bi-directional e-referral structures, implementing or expanding team-based care, and improving the capacity of the cardiovascular disease workforce to address social determinants of health (SDOH).

Eligible applicants will submit grant applications through the Department's System for Administering Grants Electronically (SAGE), in accordance with the Request for Applications (RFA). The RFA may be requested from the contact listed below.

The continuation application will be made available to eligible agencies on SAGE. Applicants will submit a grant application based on the Letter of Intent.
