QUALIFICATIONS NEEDED BY APPLICANT TO BE CONSIDERED FOR A GRANT:

Eligible applicants are nonprofit, tax-exempt 501(c)(3) community-based organizations (tax exempt status documentation must be provided). Examples of CBOs include civic and social organizations, faith-based organizations, and other non-traditional partners that have a track record of and the capacity to educate and engage vulnerable communities. Applicants that have experience in past MIECHV programs will be given preference.

APPLICATION PROCEDURES:

Eligible applicants will submit grant applications through the Department's System for Administering Grants Electronically (SAGE), in accordance with the Request for Applications (RFA). The RFA may be requested from the contact listed below.

Applicants must have a valid NJ Charities Registration Letter and Tax Clearance Certificate to apply. A grant application will be made available to all "eligible" agencies in the System for Administering Grants Electronically (SAGE), <https://dohsage.intelligrants.com/>. The applicant will initiate and submit a grant application via "My Opportunites" on the SAGE home page by selecting the "Maternal, Infant, and Early Childhood Home Visiting Program 2026" grant program.
