In an effort to maintain its robust and comprehensive HIV surveillance and high-impact prevention programs, New Jersey's Division of HIV, STD, and TB Services (DHSTS) is seeking applications for innovative approaches to HIV prevention with the overarching goals of reducing new infections and improving the overall health outcomes of individuals at risk of contracting HIV. DHSTS places a heavy emphasis on programs that prioritize marginalized and underserved communities, including but not limited to: LGBTQ+ individuals, people of color, and individuals experiencing homelessness. This is achieved by focusing on a comprehensive, whole-person approach that supports status-neutral services, testing, linkage to care, PrEP initiation, and expansion of other scientifically proven, cost-effective interventions.
