PURPOSE FOR WHICH THE GRANT PROGRAM FUNDS SHALL BE USED:

Fund 20 municipal or county health departments (LHDs) with previously established Overdose Fatality Review Teams. All 20 teams will be funded at \$75,000 each to implement and sustain county and municipal jurisdiction OFRTs in order to identify and execute strategies to reduce overdose deaths.

QUALIFICATIONS NEEDED BY APPLICANT TO BE CONSIDERED FOR A GRANT:

Eligible LHDs are listed in the Request for Application. Only those LHDs listed are eligible to apply; only one LHD per county is eligible. Eligible applicants include New Jersey LHDs that service a population/provide core public health services to at least 25,000 residents AND demonstrate compliance with N.J.A.C 8:52-3.3 and N.J.A.C8:42-4.1 (a).
